**Comprehensive Cancer Consultation
Informed Consent and Professional Fees Agreement**

Time Period is Limited to One Day Only:

This Informed Consent is limited in that it applies only to the date that you are in consultation with Medicine of HOPE and/or Dr. Schwengel. Any further medical services by this office, Dr. Schwengel or the staff will require a new General Informed Consent to be signed.

Services are Limited:

This Informed Consent is for the purposes of holding a Comprehensive Cancer Consultation in the office. It allows you to grant to Medicine of HOPE, PC, Dr. Schwengel and his staff permission to perform basic testing procedures to give both Dr. Schwengel and you enough information to allow you have a meaningful consultation in our office and to help you make informed choices about your healthcare needs.

This includes the use of BioScan testing. BioScan is a form of Electro-Acupuncture according to Voll (EAV). BioScan is energetic evaluation of the body using computerized equipment which involves physically holding and touching your hands and fingers with electronic probes. It may also include Energy Medicine techniques such as muscle testing of an arm or other extremity, and other methods of testing or responding to questions that may a part of the consultation process.

A Comprehensive Cancer Consultation also includes a review of available medical records, a discussion and explanation of various treatment methods used in what may become an Integrative Medicine Program of Care for you including: various forms of IV therapies, Osteopathic Medicine, Homeopathic Medicine, Nutritional Medicine and Energy Medicine therapies.

Special Disclaimer for BioScan (EAV) Testing and Energy Medicine techniques:

BioScan (EAV) testing & Energy Medicine techniques are not used as or to be interpreted as being either diagnostic of or a treatment for any specific disease, condition or medical diagnosis. Treatments that may arise from BioScan (EAV) testing and/or Energy Medicine techniques are limited to helping restore the natural and normal balance of various energy systems of the body.

Consent to Consultation:

- ▶ I hereby consent to a Comprehensive Cancer Consultation with Dr. Schwengel and staff.
- ▶ I understand and agree that I will provide information about my health status, needs and desires to the best of my ability to Dr. Schwengel that he may use in this Consultation.
- ▶ I understand and agree that interpretations and applications of BioScan (EAV) testing and

Professional Fees Agreement

- ▶ I understand and agree that there is a professional fee of \$1,500 for this Comprehensive Cancer Consultation, which is due and payable at the time of the Consultation. This is a non-refundable fee.
- ▶ I understand and agree that this fee includes Dr. Schwengel’s consultation time, review and evaluation of my existing medical records, ordering any new lab and imaging tests that may be necessary, and any physical exam and BioScan (EAV) testing that may need to be done.
- ▶ This fee does not include any Homeopathic medicines, supplements or other testing procedures that may be recommended to me (see below).

Therapies and Treatments:

- ▶ Dr. Schwengel will prepare for me a written treatment plan called “Integrative Medicine Plan of Care”. I will have adequate opportunity to review this treatment plan and have my questions answered before beginning a course of therapy.
- ▶ I understand that I will be asked to sign a General Informed Consent before I can be considered a regular patient and have conventional medical or homeopathic evaluation, diagnosis and/or enter into a formal treatment plan.
- ▶ Upon mutual agreement the following may be initiated on the same day of the Consultation:
- ▶ Homeopathic remedies may be formulated and provided to you as pre-treatment support for detoxification and/or stress management purposes.
- ▶ A Heavy Metals Challenge Test may be administered. This is an actual Chelation Therapy treatment using a combination of EDTA and homeopathic medicines to draw out toxic metal ions from your body. This includes aluminum, cadmium, lead, mercury and platinum. You will collect urine for several hours and send a sample to the lab as directed. The heavy metals test result gives Dr. Schwengel information about the overall burden of toxic metals in your body.
